

Overview

The Summer Fancy Food Show is a speciality show having exhibitor booth space covering more than 330,000 square feet (nearly six football fields) of floor space at the Jacob K Javits convention centre, New York with participation of more than 2,300 domestic and global specialty food and beverage manufacturers, buyers, distributors, investors, across dozens of categories. This year was the 68th edition of the event having product pavilions categorised into Bakery; Beverage; Confectionery, Sweets & Snacks; Deli; Plant Based etc with participation of exhibitors from 56 countries, Africa, Asia, Europe, North America, Oceana, and South America, including the Show's partner country, Spain.



Consul General of India Interaction with Indian Exporters















Round Table Discussion on Food and Agri Sector on June 24, 2024

The Consulate General of India, New York organized a roundtable discussion for Exporters of Food and Agricultural Products who participated in the Summer Fancy Food Show. This event served as a crucial gathering for Indian exporters eager to explore the US market.

The primary aim of the roundtable was to provide a platform for exporters to interact with the Consul General and engage with key players in the New York restaurant and food industry. The event sought to foster meaningful connections and collaborations, enabling Indian exporters to network with prominent US buyers and stakeholders.

The Consul General opened the event with remarks on the growth potential within the Food and Agriculture market. Keynote speakers included Dr. Vijaya Lakshmi, IAS, Principal Secretary of Animal & Husbandry & Fish Resources, Government of Bihar; Dr. Yogita Rana, IAS, Joint Secretary, Agriculture & Farmers' Welfare, Ministry of Agriculture, Government of India; Dr. Saswati Bose, General Manager, APEDA; Col. Pushpam Kumar, Senior General Manager, ITPO; and Mr. Sachin Kumar, Deputy Director, TPCI who shared their insights on the sector's scope and discussed strategies for enhancing Indian exports to the US.

Dr. Saswati Bose, General Manager, Agricultural and Processed Food Products Export Development Authority (APEDA) spoke on the initiatives of APEDA for exports and the role of APEDA in facilitating exports of its scheduled products. She also informed the role of APEDA as the Secretariat in implementing the National Programme on Organic production (NPOP).

An engaging Question & Answer session followed, allowing for a robust exchange of ideas and feedback.









Key Takeaways and Recommendations:

- Several exporters / exhibitors connected with the US based buyers and distributors in food and Agri sectors.
- Several importers expressed interest in visiting production facilities in India and sought assistance in arranging such visits.
- There was a collective request for assistance in securing premium booth locations at future trade shows to enhance visibility.
- Exporters highlighted the significant potential for Indian mangoes in the US market, emphasizing New York as an optimal distribution hub due to its extensive reach.
- Suggestions were made regarding the establishment of a dedicated warehouse facility in New York to better support the logistics of Indian agricultural exports.
- Suggestions were also made to have an online / e—portal for display and marketing of Indian products.
- The Punjab delegation also mentioned plans to set up a Punjab Mart.

Outcome, Feedback and Suggestions Feedback

The feedback submitted by the exporters is summarized as under:

- India pavilion was at far end almost in an isolated area.
- Few exporters were happy with the business queries and orders generated.

Some exporters were hoping to receive/negotiate business with them in future

Suggestions:

- The Indian exporters should participate under one umbrella for better branding of the country and effective showcasing the strength of Indian products.
- Planning and adequate resource needs to be spent on publicity about the participation of India.
- Participation should be followed up with promotion programmes in retail outlets with support of Indian Embassy.
- ITPO should negotiate with the Summer Food organizers for better location of Indian pavilion.
