Dear Sir,

This has reference to the request of Singapore Food Agency of import requirement of Health certificate for export of groundnut and groundnut products from India to Singapore .

SFA has requested that below tabulated groundnuts and its products with the defined HS codes shall be accompanied by a health certificate with the following attestations:


- i) The product(s) is/are produced in an establishment approved by the competent authority for production of food intended for export;
- ii) All batches of product(s) have been tested for Aflatoxins by the competent authority and any detected levels of Aflatoxin B1 as well as total Aflatoxins (B1, B2, G1 and G2) should not exceed the maximum limit of 5 ppb (with laboratory test report attached)

Table 1: Groundnut products exported to Singapore from India which would need to be accompanied by a health certificate

HS Code	HS Description
1202 30 10	Groundnuts HPS of seed quality not roasted or cooked
1202 30 90	Other Groundnuts of seed quality not roasted or cooked
1202 41 10	Groundnuts in-shell HPS not roasted or cooked
1202 41 90	Other Groundnuts in-shell not roasted or cooked
1202 42 10	Other Groundnuts in-shell not roasted or cooked
1202 42 20	Shelled Groundnuts kernels, not roasted or cooked
1202 42 90	Shelled Groundnuts, not roasted or cooked
2008 11 00	Groundnuts, otherwise prepared or preserved, whether or not mixed together and whether or not containing added sugar or other sweetening matter or spirit, not elsewhere specified or included. (This includes Peanut Butter)

EIC is requested to kindly look after the SFA's request and start issuing Health certificate for groundnuts and groundnut products as defined above.
