EXPERIENCE

SCOPE OF WORK

- To assist APEDA for Appraisal of DPRs, indicating technical feasibility, commercial viability & sustainability and socio-economic impact.

- To Assist APEDA to Advise for release of grant linked to physical and financial performance of projects
